Re: Voluntary Recall of Certain Bakery Products Due to Possible Presence of Tiny Fragments of Metal Mesh Wire

Give and Go Prepared Foods Corp. initiated a voluntary recall today of certain bakery products sold in Canada and the United States due to the potential presence of tiny fragments of metal mesh wire. The recall commenced following notification by an ingredient supplier of the possible contamination in a supplied ingredient.

This recall is **limited solely to the Products and Lot Codes** listed. No other Give and Go products under your possession are affected.

Our records indicate that you purchased product that could be impacted. Please immediately inspect and hold this product if impacted at your warehouse(s), cease any further distribution, and remove all products from shelves.

This product should be segregated from other inventory, to ensure that it is not placed back on shelf.

If you have shipped this product to other locations, either within your own distribution system or externally, or if you have used this product as an ingredient in other foods, please immediately forward this recall notice to all recipients of the product and request that they comply with the procedures discussed above.

Please provide us with a signed certification of destruction identifying the products, date, and method of destruction.
