To Our Valued Customer:

Please be advised Conagra Brands, in cooperation with the United States Department of Agriculture (USDA), is conducting a voluntary product recall of 22,128 cases on one P.F. Chang's Home Menu item. A limited amount of P.F. Chang's Home Menu Beef and Broccoli packaging was inadvertently used during the production of P.F. Chang's Home Menu Orange Chicken. This product was then shipped in P.F. Chang's Home Menu Orange Chicken cases. P.F. Chang's Home Menu Orange Chicken contains egg which is not declared on P.F. Chang's Home Menu Beef and Broccoli packaging. Based on the presence of an undeclared allergen, the USDA has deemed this a Class I recall.

The situation is limited to the impacted items. It does not impact any product sold at P.F. Chang's restaurants or any other P.F. Chang's Home Menu or Conagra Brands products. There have been no reports of illness or injury due to the consumption of the products to date.
