Mutti has initiated this voluntary withdrawal due to a small number of reports that the thin and flexible internal BPANI (BPA Non-Intentionally Added) coating of the cans may detach from the cans' metal substrate. Mutti has been assured by its can supplier that this coating is specified, formulated, and applied specifically to be safe for use in contact with food. There have been no reports of illness or injury associated with consumption of the recalled product.

- This voluntary recall is due to a potential can-related defect in a small number of items where the inner can lining may separate from the can itself.
- The cans' coating is specified, formulated, and applied specifically to be safe for use in contact with food. However, we do not suggest that you consume the recalled product.
- There have been no reports of illness or injury associated with consumption of the recalled product.
- Mutti is voluntarily initiating this recall because those cans exhibiting this
  defect do not meet Mutti's usual high-quality standards.
- No other Mutti products are affected by this voluntary recall.
- Please return for a full refund all cans subject to this voluntary recall that are in your possession. If you've already discarded cans subject to this recall, you will receive a full refund upon presentation of proof of purchase.
